The school calendar year consists of 180 days that the children are in attendance. Each month varies from another in the amount of days attended. Due to the variance, we have broken up the Extended Day fees into 10 equal installments for your convenience. Each installment covers 18 days of childcare.

Florida state law Article VII, Section 10; requires that all services must be paid in full prior to services being rendered.

Due to state law and regulation, payments are due on the 15th of the month (with the exception of the first 2 payments). If balance is unpaid by the date in the "Covers Your Childs Care Through" box below, your child will be unable to attend Extended Day until balance is paid. *Registration Fee is Non-Refundable.*
